**INFORMATION TO CANDIDATES SEEKING ADMISSION INTO I B.PHARM. UNDER MANAGEMENT
QUOTA FOR THE YEAR 2020 - 21**

1. The College has an intake in B.PHARM as shown below:

2. The Category-B / Management Quota seats are filled as per the government order.
3. Candidates who are qualified in EAMCET-2020, and have passed two-year Intermediate Examination conducted by Board of Intermediate Examination with Mathematics/Biology Physics and Chemistry as optional or its equivalent are eligible.
4. Candidates not qualified in EAMCET - 2020, but have passed the two-year intermediate examination mentioned above with 45% (40% in case of candidates belonging to reserved category) or more aggregate are also eligible.
5. Interested candidates can submit the filled-in application form along with all enclosures (Xerox copies of EAMCET-2020 Rank Card, EAMCET-2020 Hall Ticket, SSC Marks Memo, Intermediate Marks Memo, 6th to Last Studied Study Certificate, Transfer Certificate, Conduct Certificate and Community Certificate, 4 Passport size photos). Registration fee of Rs.300/- (non-refundable) Registration fee can be paid by the applicant using credit card or debit card or through net banking or in the form of DD infavour of "St. Ann's College of Pharmacy", Payable at SBI, Chirala Prakasam District in the college between 10.00AM and 4.00PM on all working days.
6. The selection of candidates for category B seats will be based on aggregate marks in intermediate examination.
7. List of the selected candidates will be displayed on the college notice board and the college website: www.sacet.ac.in.
8. At the time of admission, the candidates selected will be required to pay the tuition fee of Rs. 35,000 as prescribed by the Government of AP for Category-B seats.
9. Candidates who wish to use college bus to come to the college have to pay another amount for the annual Bus-pass.
10. Candidates admitted under B category seats are not eligible for any kind of Government Scholarships.
11. Fee once paid will not be refunded under any circumstances.
12. Ragging is strictly prohibited in the institution, hostels and public places.
